TRAINING DESCRIPTIONS:

S-130, S-190, L-180

Hybrid: Online beginning April 4/Field exercise Thursday 6/13 from 0800 to 1630 (TNC Southern Maine Field Office, Wells Maine)

Description: The course addresses the foundational skills universal to all wildland firefighters. The material is divided into 12 online modules (1 to 3 hours each) and a mandatory, instructor-led field exercise. Each online module explains the concepts and skills that will be performed and evaluated on the field exercise.

Prerequsites: None

Bring: Hardhat, gloves, safety glasses, long pants, long sleeved shirt, boots. (PPE can be provided)

S-131, Firefighter Type 1

Monday 6/10 0800 to 1630 and Tuesday 6/11 0800 to 1200 (York County EMA)

Description: S-131, Firefighter Type 1 is designed to meet the training needs of the Firefighter Type 1

(FFT1) and/or Incident Commander Type 5 (ICT5). Topics include operational leadership,

communications, LCES, and tactical decision-making.

Prerequisites: Students must be qualified as Firefighter Type 2 (FFT2).

Bring: IRPG and note taking-material, PPE is not required.

S-211, Portable Pumps and Water Use

Wednesday 6/12 0800 to 1630 and Thursday 6/13 0800 to 1630 (Massabesic Experimental Forest)

Description: This course is designed to provide knowledge and skills to design, setup, operate, troubleshoot, and shut down portable water delivery systems. The focus is on portable pumps – it does not address water delivery for engines. Topics covered include: portable water delivery systems; equipment; roles and responsibilities; and system design and hydraulics. There is also a field exercise where students will apply what they learned in the classroom.

Prerequisites: None.

Bring: IRPG, gloves, eye protection, hearing protection, helmet, drinking water, field clothes, fire boots, rain gear, and note-taking material.

G-131, Firefighter Type 1 for the Structural Firefighter

Tuesday 6/11 0800 to 1630 (York County EMA)

Description: This course is designed to provide wildland firefighting skills (Firefighter Type 1) to structural firefighters who meet NFPA 1001 for Structural Firefighter 2 or equivalency.

Prerequsites: Structural firefighters who meet NFPA 1001 for Structural Firefighter Type 2.

Bring: IRPG and note-taking material, PPE is not required.

First Aid/CPR & Blood Borne Pathogens

Wednesday 1800 to 2200 (York County EMA)

Description: This course equips students to recognize and care for a variety of breathing and cardiac emergencies, as well as how to avoid exposure to and mitigate the spread of bloodborne pathogens.

Prerequisites: None

Bring: Note-taking materials

UTV Safety & Use

Friday 6/14 0800 to 1630 (TNC Southern Maine Field Office, Wells)

Description: This course is designed to provide operators of utility terrain vehicles (UTVs) with the skills and knowledge necessary to operate these vehicles in a safe and responsible manner in the wildland fire environment.

Prerequisite: None

Bring: UTV required. PPE: gloves, eye protection, hearing protection, helmet, drinking water, field clothes, boots, rain gear, and note-taking material.
